### PLANNING COMMISSION

The Commission meets on the 2<sup>nd</sup> Thursday of each month and, if necessary, the 4<sup>th</sup> Thursday

The **Planning Commission** consists of five (5) members who reside within the City and/or its designated spheres and serves in an advisory capacity to the City Council on land use policy planning matters. Commissioners have final approval authority on certain matters and recommend action to the City Council on others. The Commission conducts review of all types of development projects and individual land use requests such as subdivisions, specific plans, conditional use permits, and planned developments. They assist the Council in the formulation of policies and ordinances that implement the General Plan such as amendments to the Development Code, the adoption of new code sections, and changes to the existing zoning text and maps, etc.

**PUBLIC SAFETY ADVISORY COMMITTEE**


Meets Annually on the 2<sup>nd</sup> Tuesday @ 6:00 p.m. in January or as needed
